## 1.0 **Specifications**

Seeking bids for ten (10) residential front load washers and ten (10) matching electric dryers for use in the households of Pine Valley Healthcare and Rehabilitation Center (25951 Circle View Lane, Richland Center, WI). Stainless steel exterior finish.

The fact that we may specify a manufacturer and model number is not meant to limit acceptable products; rather it is a means to establish a MINIMUM LEVEL of acceptable quality. You may bid any manufacturer and model as long as the products you bid are equal to or exceed the required specifications. Richland County-Pine Valley is the sole judge of equivalency in the units.

The fact that all standard equipment may not be mentioned in the minimum specification listing does not permit a bidder to leave out any item or part shown as standard in the manufacturer's detailed cuts and specifications.

If a washer or dryer is bid which is different than the model listed below, the bidder must include detailed specifications and information on the unit bid, as well as a comparison of the unit being bid vs. the specified 5.2 cu.ft. front load washer unit., and 7.4 cu.ft. front-load electric dryer with steam. The comparison must clearly list the main features and sizing of each unit compared to each other (i.e". there are more shelves in this unit than on the unit specified", or "the freezer is on the top instead of the bottom"), this is in addition to the specification sheet of the unit being proposed.

## If a bidder fails to provide this information, their bid will be rejected.

In addition the vendor is responsible for site clearing (disposal, recycling, etc).

Only new equipment is acceptable, no used, demoed or refurbished equipment will be accepted.

#### 3.0 **Bid Submittal**

Failure to provide all requested information mayl result in the rejection of your bid.

Richland County reserves the right to request clarifications for any bid.
